1	WHEREAS,	the SAN XAVIER DISTRICT has been approved to receive Federal Transportation
2		Enhancement funding through the Arizona Department of Transportation
3		(ADOT) and the Regional Transportation Authority (RTA) for the design review
4		and construction of the project named Mission Gateway Pathway, at a projected
5		cost of \$700,100; and
6	WHEREAS,	the Transportation Enhancement program is administered by the Federal
7	İ	Highway Administration (FHWA) and application is made to ADOT through the
8		Pima Association of Governments (PAG), in which an Agreement is entered into
9		between ADOT and the District; and
10	WHEREAS,	the District has negotiated an Agreement denominated JPA 11-048-I attached
11		hereto, using ADOT's standard form of Intergovernmental Agreement which
12		calls for dispute resolution by arbitration, with a limited waiver of the District's
13	:	sovereign immunity in connection with that procedure; and
14	WHEREAS,	the Tohono O'odham Legislative Council must give approval to the District to
15		include a limited waiver of the District's sovereign immunity in any contract to
16		which the District is a party; and
17	WHEREAS,	the San Xavier District Council, in its Resolution 10-15-6, requests approval from
18		the Tohono O'odham Legislative Council to waive its sovereign immunity as
19		limited by the terms of the JPA; and
20	WHEREAS,	the Legislative Council considered and approved similar language in an ADOT
21		contract with the San Xavier District in Resolution No. 15-402; and
22	WHEREAS,	this matter has been reviewed by the Legislative Agricultural and Natural
23		Resources Committee, which recommends that the Legislative Council confirm
24		San Xavier District's authority to enter into the JPA.
25	NOW, THERE	FORE, BE IT RESOLVED:
26		1. The Nation approves a limited waiver of the District's sovereign
27		immunity to support the dispute resolution and indemnification
28		provisions in the Joint Project Agreement IPA 11-0048-I between the San
