(Approving FY2016 Hickiwan District Budgets)**

**RESOLUTION NO. 15-468**

1 **WHEREAS, Tohono O'odham Legislative Council enacted Resolution No. 15-325, "Approving**  
2 **FY 2016 District Allocation and Apportionment of Gaming Revenues to Districts**  
3 **by Equal Distribution"; and**

4 **WHEREAS, the apportionment for the Hickiwan District is in the amount of \$1,615,811.13**  
5 **and is made available for expenditure subject to an approved budget in**  
6 **accordance with Article VI, Section 1(d)(2) and Article IX, Section 7 of the Nations**  
7 **Constitution; and**

8 **WHEREAS, Hickiwan District requested a continuing resolution which was granted by**  
9 **Tohono O'odham Legislative Council Resolution 15-377 pending an approved**  
10 **budget; and**

11 **WHEREAS, Hickiwan District prepared and approved FY 2016 Budgets for the District**  
12 **Administration and its communities by District Resolution No. HDC-15-050; and**

13 **WHEREAS, the Budget and Finance Committee of the Legislative Council has reviewed the**  
14 **attached Budgets and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
16 **approves FY 2016 Hickiwan District budgets in the amount of \$1,615,811.13 of**

1 funds or funding level is submitted for further prior approval by the Tohono  
2 O'odham Legislative Council.

3 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23<sup>RD</sup>  
4 day of NOVEMBER, 2015 at a meeting at which a quorum was present with a vote of 2,654.2 FOR;  
5 -0- AGAINST; -0- NOT VOTING; and 367.2 [06] ABSENT, pursuant to the powers vested in the  
6 Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation,  
7 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting  
8 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
9 16 of the Act of June 18, 1934 (48 Stat.984).
