4	į.	Council has for some years selected Wells Fargo Bank as the custodian and
5		investment manager of the Nation's Minors' Per Capita Trust; and
6	WHEREAS,	in FY 2009, the Nation retained Portfolio Evaluations, Inc. as an independent
7		investment consultant to advise the Nation regarding the investment choices
8		made or recommended by Wells Fargo Bank and by any subsequent or
9		additional investment advisors that may be retained by the Nation; and
10	WHEREAS,	under the contract, the Investment Consultant will report as reasonably
11		necessary to the Investment Committee and will, at a minimum, provide two
12		presentations to the full Legislative Council per year; and
13	WHEREAS,	the term of the contract will be from October 1, 2015 through September 30,
14		2016, and the financial arrangement will be a flat retainer fee for services
15		relating to the Nation's Minors' Per Capita Trust in the amount of \$20,000.00;
16		and
17	WHEREAS,	the source of funds for the consultant fee will be the Nation's general fund,
18		which will be reimbursed by the Nation's Minors' Per Capita Trust; and
19	WHEREAS,	the Investment and Budget and Finance Committees recommend approving the
20		Portfolio Evaluation's FY2016 contract as the investment advisor for the Minor's
21		Per Capita Trust until September 30, 2016.
22	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
23		1. Approves the Investment Consultant Contract with Portfolio Evaluations,
24		Inc., as the Investment Consultant for the Nation relating to the Minors'
25		Per Capita Trust, substantially in the form attached hereto, for the period
26		from October 1, 2015 through September 30, 2016; and
27		2. Approves the consultant fees to be paid from the Nation's general fund,
28		which will be reimbursed from the Nation's Minors' Per Capita Trust; and
29		3. Authorizes the Chairman of the Nation to execute the contract, provided
30		that any amendments or extensions to the Investment Consultant Contract
31		shall be presented to the Legislative Council for further approval.
