

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving amendment #1 to the FY 2016 Florence KOHF-LP Radio Project budget)**

**RESOLUTION NO. 15-475**

1 **WHEREAS,** by resolution 15-399, *Amending Resolution No. 15-237, "Approving and*  
2 *authorizing an appropriation and allocating general fund surplus for FY 2015*  
3 *Florence KOHF-LP Radio Project budget"* to Extend the Budget Authority to FY  
4 *2016*, the Florence KOHF-LP Radio Project appropriation budget authority was  
5 extended into fiscal year 2016; and

6 **WHEREAS,** Hewel Ni'ok, managers and operators of the Nation's licensed radio stations, has  
7 prepared the attached budget amendment # 1 to reallocate resources to  
8 expenses required to complete the Radio Project; and

9 **WHEREAS,** the amendment reallocates funds from operational to the capital construction  
10 portion of the budget to provide for increased expenses in site preparation and  
11 the need to conduct a legal survey for the purpose of obtaining the required  
12 easements and rights of way; and

13 **WHEREAS,** the amendment further creates account 8020 – Soil and Surveys to facilitate the  
14 legal survey necessary for the issuance of the easements and rights of way; and

15 **WHEREAS,** the Culture Preservation and the Budget and Finance Committees of the Tohono  
16 O'odham Legislative Council have reviewed this budget amendment and  
17 recommend its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves  
19 and authorizes amendment # 1 to the Florence KOHF-LP Radio Project as  
20 provided in the attached budget amendment.

21 **BE IT FURTHER RESOLVED** that the amendment creates and allocates funds for account 8020 –  
22 Soil and Surveys to facilitate the legal survey necessary for the issuance of  
23 easements and rights of way.

24 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council authorizes the  
25 Chairman and any designated official to expend and administer the budget as  
26 attached, provided that any amendments affecting the funds or funding level is  
27 submitted for further prior approval by the Tohono O'odham Legislative


