**RESOLUTION NO. 15-476**

1 **WHEREAS, Baboquivari District Officials presented Budget Amendment # 1 for Choulic**  
2 **Community's FY 2016 Budget (see attached Budget); and**

3 **WHEREAS, the Budget Amendment # 1 for Choulic Community's FY 2016 Budget would add**  
4 **additional language in the justification for 7000 - Office Supplies, 7005 - Supplies**  
5 **Office Equipment, 7010 - Program Supplies, 7100 - Utilities, 7615 -**  
6 **Donation/Contribution and 7640 - Miscellaneous line items; and**

7 **WHEREAS, the FY 2016 Budget Amendment # 1 will not affect Choulic Community's FY 2016**  
8 **current budget of \$213,214.75, nor the overall Baboquivari District's FY 2016**  
9 **Budget of \$2,135,581.84; and**

10 **WHEREAS, the Budget and Finance Committee of the Tohono O'odham Legislative Council**  
11 **has reviewed the attached budget and recommends its approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
13 **approves Budget Amendment # 1 for Choulic Community's FY 2016 Budget to**  
14 **add language.**

15 **BE IT FURTHER RESOLVED that the Amendment #1 will not affect Choulic Community's FY**  
16 **2016 current budget amount of \$213,214.75, nor will it affect the overall**  
17 **Baboquivari District's FY 2016 budget in the amount of \$2,135,581.84.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
19 **District Chairperson and any designated official to expend and administer the**  
20 **Budget as attached, provided that any Modifications/Amendments affecting the**  
21 **funds or funding level is submitted for further prior approval by the Tohono**  
22 **O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>**  
24 **day of DECEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
25 **-0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**  
26 **Article VI, Sections 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
29 **June 18, 1934 (48 Stat.984).**
