## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Enacting 7 Tohono O'odham Code Chapter 1 – Criminal Code, Section 9.15 Voyeurism)

1	WHEREAS,	the Legislative Council is vested with the power "to enact criminal and civil laws
2		governing the conduct of any person within the Tohono O'odham Nation" and to
3		provide laws "to promote, protect and provide for public health, peace, morals
4		education and general welfare of the Tohono O'odham Nation and its members'
5		(Constitution of the Tohono O'odham Nation, Article VI, Section 1(c)(6) and
6		1(c)(2)); and
7	WHEREAS,	the Tohono O'odham Legislative Council has enacted the Tohono O'odham
8		Criminal Code, as amended, to define criminal offenses, establish sentencing
9		guidelines, define the Judicial Court's jurisdiction in criminal actions, and to
10		otherwise govern the enforcement of the Nation's criminal laws (7 T.O.C.
11		Chapter 1); and
12	WHEREAS,	in response to public safety concerns raised by Nation's members, the Domestic
13		Affairs Committee has drafted Criminal Code Section 9.15 Voyeurism which by
14		enactment of this law will criminalize voyeurism; and
15	WHEREAS,	the Domestic Affairs Committee distributed the draft law for public comment,
16		incorporated public input, and now recommends that the Legislative Council
17		enact 7 Tohono O'odham Code Chapter 1 - Criminal Code, Section 9.15
18		Voyeurism as dated for reference December 2015, which is incorporated by this
19		reference, as an additional tool for protecting public safety.
20	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council enacts 7
21 22		Tohono O'odham Code Chapter 1 - Criminal Code, Section 9.15 Voyeurism,
