

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Enacting 7 Tohono O'odham Code Chapter 1 - Criminal Code, Section 9.15 Voyeurism)**

RESOLUTION NO. 15-477

1 **WHEREAS, the Legislative Council is vested with the power "to enact criminal and civil laws**
2 **governing the conduct of any person within the Tohono O'odham Nation" and to**
3 **provide laws "to promote, protect and provide for public health, peace, morals,**
4 **education and general welfare of the Tohono O'odham Nation and its members"**
5 **(Constitution of the Tohono O'odham Nation, Article VI, Section 1(c)(6) and**
6 **1(c)(2)); and**

7 **WHEREAS, the Tohono O'odham Legislative Council has enacted the Tohono O'odham**
8 **Criminal Code, as amended, to define criminal offenses, establish sentencing**
9 **guidelines, define the Judicial Court's jurisdiction in criminal actions, and to**
10 **otherwise govern the enforcement of the Nation's criminal laws (7 T.O.C.**
11 **Chapter 1); and**

12 **WHEREAS, in response to public safety concerns raised by Nation's members, the Domestic**
13 **Affairs Committee has drafted Criminal Code Section 9.15 Voyeurism which by**
14 **enactment of this law will criminalize voyeurism; and**

15 **WHEREAS, the Domestic Affairs Committee distributed the draft law for public comment,**
16 **incorporated public input, and now recommends that the Legislative Council**
17 **enact 7 Tohono O'odham Code Chapter 1 - Criminal Code, Section 9.15**
18 **Voyeurism as dated for reference December 2015, which is incorporated by this**
19 **reference, as an additional tool for protecting public safety.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council enacts 7**
21 **Tohono O'odham Code Chapter 1 - Criminal Code, Section 9.15 Voyeurism,**
22 **which shall become effective on the date this resolution takes effect in**
23 **accordance with the Constitution of the Tohono O'odham Nation.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
25 **day of DECEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
26 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
27 **Article VI, Sections 1 (c)(6) and 1(c)(2) of the Constitution of the Tohono O'odham Nation,**
28 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
29 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
30 **16 of the Act of June 18, 1934 (48 Stat.984).**
