

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the Intergovernmental Agreement between the City of Tolleson and the**  
**Tohono O'odham Nation for Dispatch and Records Management Services)**

**RESOLUTION NO. 15-483**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "consult,**  
2 **negotiate and conclude agreements and contracts on behalf of the Tohono**  
3 **O'odham Nation ("Nation") with the Federal, State, and local governments..."**  
4 **(Constitution of the Tohono O'odham Nation, Article VI, Section 1(f)); and**

5 **WHEREAS, 24 hour Police Services are required at the interim West Valley Casino; and**

6 **WHEREAS, the Nation desires to contract with Tolleson to provide dispatch and records**  
7 **management services; and**

8 **WHEREAS, the fee to be paid to the City of Tolleson for their services is \$8,350.00 per month**  
9 **until June 30, 2016; and**

10 **WHEREAS, the Domestic Affairs and Budget and Finance Committees of the Legislative**  
11 **Council have reviewed this Intergovernmental Agreement and recommend its**  
12 **approval.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
14 **approves the Intergovernmental Agreement between the City of Tolleson and**  
15 **the Tohono O'odham Nation substantially in the form attached hereto.**

16 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
17 **authorizes the Chairman and any designated official to enter into this**  
18 **agreement, provided that any amendments affecting the funds or funding level**  
19 **shall be submitted for further prior approval by the Tohono O'odham**  
20 **Legislative Council.**

21 **BE IT FINALLY RESOLVED that the Nation hereby grants a limited waiver of sovereign**  
22 **immunity of the Nation in order to enforce the terms of the Intergovernmental**  
23 **Agreement.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>**  
25 **day of DECEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
26 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
27 **Article VI, Sections 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
28 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
30 **June 18, 1934 (48 Stat.984).**
