2 **authorized the fiscal year 2016 budget of Hewel Ni'ok as a part of the Executive**
3 **Branch fiscal year 2016 budget; and**

4 **WHEREAS, Hewel Ni'ok management has prepared the attached Amendment #1 which**
5 **provides additional allocations for operational line items including the new**
6 **account 7060 - Food; and allocating non-recurring funds to accounts 7345 -**
7 **Consultants and 7618 - Honorariums; and**


8 **WHEREAS, the Cultural Preservation and the Budget and Finance Committees of the**
9 **Legislative Council have reviewed this Budget and recommend its approval.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the**
11 **attached budget amendment #1 for the Hewel Ni'ok's FY 2016 budget is hereby**
12 **approved and authorized as presented to provide additional allocations for**
13 **operational line items including the new account 7060 - Food and allocating**
14 **non-recurring fund to accounts 7345 - Consultants and 7618 - Honorariums.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
16 **Chairman and any designated official to expend and administer the budget as**
17 **attached, provided that any amendments affecting the funds or funding level is**
18 **submitted for further prior approval by the Tohono O'odham Legislative**
19 **Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
21 **day of DECEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
22 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
23 **Article VI, Sections 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the**
24 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
26 **June 18, 1934 (48 Stat.984).**
