

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Legislative Branch Budget Amendment No. 1)**

RESOLUTION NO. 15-490

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**
2 **control of the Tohono O'odham Nation...and to appropriate these funds for the**
3 **benefit of the nation and its members" provided that "[a]ll expenditures of these**
4 **funds shall be pursuant to appropriations or budgets" authorized by resolution**
5 **or ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section**
6 **1(d)(2)); and**

7 **WHEREAS, the Legislative Branch FY 2016 budget was approved by Resolution No. 15-166;**
8 **and**

9 **WHEREAS, the Legislative Branch administration has prepared and submitted for review**
10 **and approval its FY 2016 Budget Amendment No. 1, which is incorporated by this**
11 **reference and which (1) reclassifies Transcriber positions to Committee Staff; (2)**
12 **reduces expenses in 6000 Salaries, 6010 Leave, 6110 FICA, 6120 Workers Comp,**
13 **6130 Unemployment Expenses, 6205 Employer Health, 6215 Employer Dental,**
14 **6220 Employer Life Insurance, 6230 Employer Long Term Disability, 6235**
15 **Employer Short Term Disability, and 6240 Employer Matching 401K; and (3)**
16 **increases line items 7000 Supplies - Office, 7210 Dues and Subscriptions, 7340**
17 **Public Relations, and 7365 Committee Fees; and**

18 **WHEREAS, FY 2016 Legislative Branch Budget Amendment No. 1 will not increase the**
19 **amount of funds originally appropriated to Legislative Branch FY 2016 Budget;**
20 **and**

21 **WHEREAS, the FY 2016 Legislative Branch Budget Amendment No. 1 has been reviewed by**
22 **the Budget and Finance Committee and recommends its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
24 **the FY 2016 Legislative Branch Budget Amendment No. 1 effective on the date of**
25 **this resolution.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
27 **O'odham Nation Legislative Council Chairperson and Vice-Chairperson are**
28 **authorized to administer the FY 2016 Legislative Branch Budget as amended,**
29 **provided however, that any amendments affecting these funds or funding levels**
30 **budgeted shall be submitted for prior approval by the Tohono O'odham**
31 **Legislative Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH day of DECEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI, Sections 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


