

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution No. 15-433 to Add Resolution No. 2000-003)**

**RESOLUTION NO. 15-494**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Section 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications**  
7 **and making recommendations to the Legislative Council regarding the**  
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**  
9 **and**

10 **WHEREAS, the Enrollment Program has determined that a number of resolutions**  
11 **approving applicants for membership contain misspellings in the names of**  
12 **applicants or incorrect roll numbers; and**

13 **WHEREAS, the Enrollment Program brought forward Resolution No. 15-433 to correct the**  
14 **names and/or roll numbers of members; and**

15 **WHEREAS, the Enrollment Program has discovered that Resolution No. 2000-003 was not**  
16 **included within Resolution No. 15-433 even though the resolution's attachment,**  
17 **Amending Enrollment Resolution List November 2015, included the correct**  
18 **name; and**


19 **WHEREAS, the Enrollment Program therefore recommends that Resolution No. 15-433 be**  
20 **amended to include Resolution No. 2000-003, which is being amended to add the**  
21 **correct name for the individual identified in the attached Amending Enrollment**  
22 **Resolution List November 2015 Amendment No. 1, which is incorporated by this**  
23 **reference.**

24 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**  
25 **Resolution No. 15-433 is accordingly amended upon the effective date of that**  
26 **resolution to add Resolution No. 2000-003 and the corrected name for the**  
27 **individual identified in the Amending Enrollment Resolution List November**  
28 **2015 Amendment No. 1.**

1 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>th</sup>  
2 day of DECEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;  
3 -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
4 Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono  
5 O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved  
6 by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,  
7 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


