4	WHEREAS,	the Tohono O'odham Nation has prepared a proposal for a Christmas bonus to
5		each employee of the Executive Branch, Judicial Branch, and the Legislative
6		Branch including all appointed and elected officials; and
7	WHEREAS,	it is proposed that full-time employees of the Executive Branch, Judicial Branch
8		and Legislative Branch shall each receive a \$500 Christmas bonus, provided that
9	į	employees hired on or after December 10, 2015 shall not be eligible for a
10		Christmas bonus; and
11	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves a
12		\$500 Christmas bonus for full-time Nation's employees hired before December
13		10, 2015, including all appointed and elected officials of the Executive Branch,
14		Judicial Branch, and the Legislative Branch; provided that the bonus shall be
15		issued on December 22, 2015 or as soon as possible thereafter.
16	BE IT FINALL	Y RESOLVED that the Tohono O'odham Legislative Council appropriates from the
17		FY 2016 General Fund Surplus \$836,335.50 in accordance with the following
18		estimated schedule for the Christmas bonus.
