

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Christmas Bonus for Full-Time Employees and Officials of the
Executive Branch, Judicial Branch, and the Legislative Branch)

RESOLUTION NO. 15-496

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to manage**
2 **any funds within the exclusive control of the Tohono O'odham Nation"**
3 **(Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2); and**

4 **WHEREAS, the Tohono O'odham Nation has prepared a proposal for a Christmas bonus to**
5 **each employee of the Executive Branch, Judicial Branch, and the Legislative**
6 **Branch including all appointed and elected officials; and**

7 **WHEREAS, it is proposed that full-time employees of the Executive Branch, Judicial Branch**
8 **and Legislative Branch shall each receive a \$500 Christmas bonus, provided that**
9 **employees hired on or after December 10, 2015 shall not be eligible for a**
10 **Christmas bonus; and**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves a**
12 **\$500 Christmas bonus for full-time Nation's employees hired before December**
13 **10, 2015, including all appointed and elected officials of the Executive Branch,**
14 **Judicial Branch, and the Legislative Branch; provided that the bonus shall be**
15 **issued on December 22, 2015 or as soon as possible thereafter.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council appropriates from the**
17 **FY 2016 General Fund Surplus \$836,335.50 in accordance with the following**
18 **estimated schedule for the Christmas bonus.**
