

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Enrollment Resolution Nos. 98-174, 98-357, 98-429, and 15-389  
to Correct Names of Enrollment Applicants and/or Roll Numbers)**

**RESOLUTION NO. 16-002**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications**  
7 **and making recommendations to the Legislative Council regarding the**  
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**  
9 **and**

10 **WHEREAS, the Enrollment Program has determined that a number of resolutions**  
11 **approving applicants for membership contain misspellings in the names of**  
12 **applicants and/or incorrect roll numbers; and**

13 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 98-174, 98-**  
14 **357, 98-429, and 15-389 be amended to reflect the correct name spelling and/or**  
15 **roll numbers for the individuals identified in the Amending Enrollment**  
16 **Resolution List January 2016, which is incorporated by this reference.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**  
18 **Resolution Nos. 98-174, 98-357, 98-429, and 15-389 are amended upon the**  
19 **effective date of those resolutions to reflect the corrected names or roll**  
20 **numbers identified in the Amending Enrollment Resolution List January 2016.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>**  
22 **day of JANUARY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
23 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
24 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**  
25 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**  
26 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
27 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**


