

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY16 Child Care & Development Fund-Mandatory Budget Amendment #1)**

RESOLUTION NO. 16-009

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the power "to adopt, approve and amend annual budgets and to authorize**
3 **the expenditure of funds in accordance with these budgets." (Constitution,**
4 **Article VI, Section 1(d)(3)); and**

5 **WHEREAS, the United States Department of Health and Human Services, Administration for**
6 **Children and Families has awarded the Tohono O'odham Nation a Child Care &**
7 **Development Fund Grant for Fiscal Year 2016 to implement Child Care Services**
8 **through the Nation's Division of Early Childhood Development; and**

9 **WHEREAS, the FY2016 Notice of Grant Award dated October 19, 2015 reflects an increase in**
10 **the Child Care & Development Fund - Mandatory Allotment to \$617,886.00; and**

11 **WHEREAS, the FY 2016 Department of Health and Human Services Child Care &**
12 **Development Fund-Mandatory Budget was approved by Tohono O'odham**
13 **Legislative Council Resolution No. 15-185; and**

14 **WHEREAS, the Department of Education has proposed a Budget Amendment to create the**
15 **following line items: 6500 Training Fees and Registration; 6600 Employee**
16 **Tuition Aid; 6700 Awards-Clients; 6725 Awards-Employees; 7000 Supplies Office;**
17 **7005 Supplies Office Equipment; 7060 Food; 7200 Freight/Postage; 7210 Dues**
18 **and Subscriptions; 7310 Employee Security Clearances; 7410 RM Vehicles; 7420**
19 **RM Building; and**

20 **WHEREAS, the proposed Budget amendment will increase the line items for Operational**
21 **Expenses and Indirect Cost, per the attached budget; and**

22 **WHEREAS, the proposed Budget Amendment adjusts the indirect cost rate to a 15% cap; and**

23 **WHEREAS, the Human Resources Development and the Budget and Finance Committees**
24 **have reviewed this Budget Amendment and recommend its approval by the**
25 **Legislative Council.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
27 **approves the FY16 Child Care & Development Fund-Mandatory Budget**
28 **Amendment #1 attached hereto.**

8 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
9 **Article VI, Section 1(d)(2)(3) and 1(f) of the Constitution of the Tohono O'odham Nation, adopted**
10 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
11 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
12 **the Act of June 18, 1934 (48 Stat.984).**
