

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY16 Child Care & Development Fund-Discretionary Budget Amendment #1)

RESOLUTION NO. 16-010

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the power "to adopt, approve and amend annual budgets and to authorize**
3 **the expenditure of funds in accordance with these budgets." (Constitution,**
4 **Article VI, Section 1(d)(3)); and**

5 **WHEREAS, the United States Department of Health and Human Services, Administration for**
6 **Children and Families, has awarded the Tohono O'odham Nation a Child Care &**
7 **Development Fund Grant for Fiscal Year 2016 to implement Child Care Services**
8 **through the Nation's Division of Early Childhood Development; and**

9 **WHEREAS, the FY2016 Notice of Grant Award dated October 19, 2015 reflects an increase in**
10 **the Child Care & Development Fund - Discretionary Allotment to \$561,733.00;**
11 **and**

12 **WHEREAS, the FY 2016 Department of Health and Human Services Child Care &**
13 **Development Fund-Discretionary Budget was approved by Tohono O'odham**
14 **Legislative Council Resolution No. 15-185; and**

15 **WHEREAS, the Department of Education has proposed a Budget Amendment to create the**
16 **following line items: 6035 Allowance and Stipends; 6510 Lodging; 6520 Per Diem;**
17 **6530 Transportation; 7010 Program Supplies; 7015 Uniforms; 7020 Kitchen**
18 **Supplies; 7340 Public Relations; 7355 Professional Services; 7430 RM Grounds;**
19 **7665 Client Support; and**

20 **WHEREAS, the proposed Budget amendment will increase the line items for Operational**
21 **Expenses and Indirect Cost, per the attached budget; and**

22 **WHEREAS, the proposed Budget Amendment adjusts the indirect cost rate to a 15% cap; and**

23 **WHEREAS, the Human Resources Development and the Budget and Finance Committees**
24 **have reviewed this Budget Amendment and recommend its approval by the**
25 **Legislative Council.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
27 **approves the FY16 Child Care & Development Fund-Discretionary Budget**
28 **Amendment #1 attached hereto.**

1 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
2 **Chairperson and any designated official to expend and administer the budget as**
3 **attached, provided that any amendments affecting the funds or funding level is**
4 **submitted for further prior approval by the Tohono O'odham Legislative**
5 **Council.**

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
7 **day of JANUARY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
8 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
9 **Article VI, Section 1(d)(2)(3) and 1(f) of the Constitution of the Tohono O'odham Nation,**
10 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
11 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
12 **16 of the Act of June 18, 1934 (48 Stat.984).**


