

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Baboquivari District Administration FY 2016 Budget Amendment No. 2)

RESOLUTION NO. 16-011

1 **WHEREAS, Baboquivari District Administration presented a request of \$2,300.00 to be**
2 **transferred from Bank of America US Trust Investment Account to the**
3 **Baboquivari District Money Market Account to provide a \$500 Bonus for 4**
4 **employees including taxes; and**

5 **WHEREAS, Baboquivari District Council has authorized the transfer by Resolution 2015-B-**
6 **154 from Bank of America US Trust Investment Account to the Baboquivari**
7 **District Money Market Account; and**

8 **WHEREAS, the Administration prepared a Budget Amendment No. 2 which will affect**
9 **current Baboquivari District Administration FY 2016 budget of \$704,992.04 to a**
10 **revised amount of \$707,292.04 and will affect overall Baboquivari District FY**
11 **2016 Budget to a revised amount of \$2,137,881.84; and**

12 **WHEREAS, the Budget and Finance Committee of the Legislative Council has reviewed the**
13 **attached Budget and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
15 **approves the Baboquivari District Administration FY 2016 Budget Amendment**
16 **No. 2 and the transfer of \$2,300.00 from Bank of America US Trust Investment**
17 **Account to the Baboquivari District Money Market Account.**


18 **BE IT FURTHER RESOLVED that Amendment No. 2 will affect the Baboquivari District**
19 **Administration FY2016 Budget of \$704,992.04 to a revised amount of**
20 **\$707,292.04, and will affect overall Baboquivari District FY 2016 Budget to a**
21 **revised amount of \$2,137,881.84.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
23 **District Chairperson and any designated official to expend and administer the**
24 **Budget as attached, provided that any Modifications/Amendments affecting the**
25 **funds or funding level is submitted for further prior approval by the Tohono**
26 **O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
28 **day of JANUARY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the**
31 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
33 **June 18, 1934 (48 Stat.984).**


