

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Family Violence Prevention and Services FY 2016 Budget from
the U.S. Department of Health and Human Services Administration for
Children and Families)**

RESOLUTION NO. 16-014

1 **WHEREAS, the Domestic Violence Program within the Department of Health and Human**
2 **Services Division of Behavioral Health and the Domestic Violence Coalition are**
3 **working to raise awareness of family violence and continue the development of**
4 **services for domestic violence victims and their families; and**

5 **WHEREAS, the Nation has received a Family Violence Prevention and Services Grant award**
6 **in the amount of \$68,694.00 for the period of October 1, 2014 to September 30,**
7 **2016; and**

8 **WHEREAS, the Health and Human Services and Budget and Finance Committees of the**
9 **Legislative Council have reviewed this budget and recommend its approval.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 11 **1. Accepts and approves the Family Violence Prevention Grant award and**
12 **its FY 2016 budget, as attached, from the U.S. Department of Health and**
13 **Human Services Administration for Children and Family Violence**
14 **Prevention and Services effective October 1, 2015 through September 30,**
15 **2016.**
- 16 **2. Authorizes expenditure of funds in the amount of \$68,694.00 and to**
17 **utilize the Nation's resources pending reimbursement from the grantor**
18 **for the continuation of this grant.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairperson and any designated official to expend and administer the budget as**
21 **attached, provided that any amendments affecting the funds or funding level is**
22 **submitted for further prior approval by the Tohono O'odham Legislative**
23 **Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
25 **day of JANUARY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
26 **~~-0-~~ AGAINST; ~~-0-~~ NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
27 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**
28 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
30 **June 18, 1934 (48 Stat.984).**




