RESOLUTION NO. 16-015

1 **WHEREAS, the Domestic Violence Program, within the Department of Health and Human**
2 **Services Division of Behavioral Health, and the Domestic Violence Coalition are**
3 **working to raise awareness of domestic violence and to develop services for**
4 **domestic violence victims and the community; and**

5 **WHEREAS, the Domestic Violence Program received an award, dated November 3, 2015**
6 **from the Office of Indian Health Service for Domestic Sexual Violence in the**
7 **amount of \$49,750.00 for the first year funding of a five year grant project period**
8 **that covers September 30, 2015 to September 29, 2020; and**

9 **WHEREAS, the Domestic Violence Kom Ckud Ki budget for FY 2016 is attached; and**

10 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**
11 **Legislative Council have reviewed this budget and recommend its approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
13 **accepts the Office of Indian Health Service Domestic Sexual Violence Program**
14 **Grant in the amount of \$49,750.00 and approves the Domestic Violence Kom**
15 **Ckud Ki Budget for FY 2016 and to utilize the Nation's resources pending**
16 **reimbursement from the Grantor.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **Chairperson and any designated official to expend and administer the budget as**
19 **attached, provided that any amendments affecting the funds or funding level is**
20 **submitted for further prior approval by the Tohono O'odham Legislative**
21 **Council.**


22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**


