

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Budget Amendment #1 to the FY2016 Office of the Treasurer Budget)**

RESOLUTION NO. 16-016

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2016 Office of the**
2 **Treasurer Budget pursuant to Legislative Council Resolution No. 15-165; and**

3 **WHEREAS, the Office of the Treasurer submits for review and approval FY2016 Budget**
4 **Amendment #1; and**

5 **WHEREAS, the proposed amendment will provide funds to pay for legal expenses incurred**
6 **to prepare for a proposal Margin Loan for the Nation; and**

7 **WHEREAS, line item 7345 Consultants is created to allow for a total one time increase of**
8 **\$17,811.00 to the FY2016 Office of the Treasurer Budget; and**

9 **WHEREAS, the FY2016 Office of the Treasurer Budget Amendment #1 has been reviewed by**
10 **the Budget and Finance Committee of the Legislative Council recommend its**
11 **approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
13 **approves Amendment #1 to the FY2016 Office of the Treasurer Budget and**
14 **appropriates \$17,811.00 from general fund surplus.**

15 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes an**
16 **increase to line item 7345 Consultants by \$17,811.00, for a total one time**
17 **increase to the FY2016 Office of the Treasurer Budget to \$567,535.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
19 **Chairperson and any designated official to expend and administer the budget as**
20 **attached, provided that any amendments affecting the funds or funding level is**
21 **submitted for further prior approval by the Tohono O'odham Legislative**
22 **Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
24 **day of JANUARY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;-0-**
25 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
26 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
29 **June 18, 1934 (48 Stat.984).**
