(Approving FY 2016 Election Program Budget Amendment No. 1)**

**RESOLUTION NO. 16-018**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 2016 Election Program**  
2 **budget, in the amount of \$180,792.00 through Resolution No. 15-165; and**

3 **WHEREAS, Election Program has prepared and submitted for review and approval FY 2016**  
4 **Budget Amendment No. 1 to create line item 7355 Professional Services and to**  
5 **decrease the Operational Expense line item; and**

6 **WHEREAS, the Rules and the Budget and Finance Committees of the Legislative Council**  
7 **have reviewed this Budget and recommend its approval.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
9 **approves the FY 2016 Election Program Budget Amendment No. 1 as attached**  
10 **hereto.**

11 **BE IT FURTHER RESOLVED that Amendment No. 1 will create line item 7355 Professional**  
12 **Services and decrease the Operational Expense line item.**

13 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
14 **Chairperson and any designated official to expend and administer the budget,**  
15 **as attached, provided that any amendments affecting the funds or funding level**  
16 **is submitted for further prior approval by the Tohono O'odham Legislative**  
17 **Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>**  
19 **day of JANUARY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
20 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
21 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
22 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
24 **June 18, 1934 (48 Stat.984).**
