

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Accepting and Approving the Inter Tribal Council of Arizona, Inc. Memorandum of**  
**Agreement for the Special Supplemental Nutrition Program for Women, Infants**  
**and Children, October 1, 2015 through September 30, 2020)**

**RESOLUTION NO. 16-021**

1 **WHEREAS, funding for the Special Supplemental Nutrition Program for Women, Infants**  
2 **and Children (WIC) Program is authorized by the Congress through Section 17 of**  
3 **the "Child Nutrition Act of 1966, as amended, and funds for such programs to**  
4 **state agencies are made available through the United States Department of**  
5 **Agriculture (USDA); and**

6 **WHEREAS, the Secretary of Agriculture is authorized to make grants to "State Agencies" for**  
7 **the purpose of administering a WIC Program; and**

8 **WHEREAS, the definition of the law, under Title 7 CFR Subpart 246.2, for state agency**  
9 **includes "an Indian tribe, band, or group recognized by the Department of the**  
10 **Interior; an intertribal council or group which is the authorized representative**  
11 **of Indian Tribes, bands or groups recognized by the Department of Interior and**  
12 **which has an ongoing relationship with such tribes, bands or groups for other**  
13 **purposes and has contracted with them to administer the programs"; and**

14 **WHEREAS, the Inter Tribal Council of Arizona, Inc. (ITCA) as the state agency and in**  
15 **accordance with Title 7 CFR Subpart 246.6(a) is required to enter into a signed**  
16 **written agreement with each Agency that sets forth the local agency's**  
17 **responsibilities for program operations as prescribed in Title 7 CFR Subpart**  
18 **246.6 (b); and**

19 **WHEREAS, the Tohono O'odham Nation has continued to serve as the local WIC Agency**  
20 **which has successfully operated the Special Supplemental Nutrition Program**  
21 **for Women, Infants and Children; and**

22 **WHEREAS, the Health and Human Services Committee have reviewed the MOA between**  
23 **ITCA and the Nation and recommends it's approval.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
25 **accept and approve the Inter Tribal Council of Arizona Memorandum of**  
26 **Agreement for the Special Supplemental Nutrition Program for Women, Infants**  
27 **and Children, October 1, 2015 through September 30, 2020.**

2 **Nation's Chairman to execute the MOA, substantially in the form attached**  
3 **hereto, and any subsequent amendments, and authorizes the Nation's**  
4 **Department of Health and Human Services, Division of Community Health**  
5 **Service, WIC Program to implement the agreement.**

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>**  
7 **day of JANUARY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
8 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
9 **Article VI, Section 1(d)(2)(3)and(f) of the Constitution of the Tohono O'odham Nation, adopted**  
10 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
11 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**  
12 **the Act of June 18, 1934 (48 Stat.984).**
