1	WHEKEAS,	the Constitution of the Tohono Codnam Nation vests the Legislative Council
2		with the authority to "provide for the maintenance of law and order and the
3		administration of justice" (Constitution, Article VI, Section 1(c)(6)); and
4	WHEREAS,	as a matter of practice, the master jury list, which is maintained by the Judicial
5		Court, has been compiled from limited enrollment information provided by the
6		Enrollment Office; and
7	WHEREAS,	the master jury list has not been updated since 1997, resulting in a limited
8		number of available potential jurors and frequent summons to Nation's
9		members for repeated jury service, thereby creating a substantial burden for
10		Nation's members appearing on the list; and
11	WHEREAS,	the master jury list amendments to 6 Tohono O'odham Code Chapter 1 and 14
12		Tohono O'odham Code Chapter 1 ("Master Jury List Amendments"), which are
13		incorporated by this reference, would expand the Court's ability to call an
14		additional number of possible jurors, while also safeguarding confidential
15		enrollment information and ensuring that such information is used by the
16		Court for the sole purpose of creating and maintaining a master jury list; and
17	WHEREAS,	the Judiciary and Rules Committees reviewed and distributed for public
18		comment the Master Jury List Amendments and recognize the immediate need
19		for an updated master jury list; and
20	WHEREAS,	it is in the Nation's best interest to adopt the Master Jury List Amendments to 6
21		Tohono O'odham Code Chapter 1 and 14 Tohono O'odham Code Chapter 1.
22	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council adopts the
23		Master Jury List Amendments to 6 Tohono O'odham Code Chapter 1-Courts and
24		Procedures and 14 Tohono O'odham Code Chapter 1- Enrollment Ordinance.
25	BE IT FINAL	LY RESOLVED by the Tohono O'odham Legislative Council that, in order to
26		facilitate the expeditious implementation of the master jury list amendments,
27		the Enrollment Director shall provide the information specified in Article X,
28		Section 5(A) of the amended Enrollment Ordinance to the chief judge within 90
29		days of the effective date of this resolution.
