RESOLUTION NO. 16-027

1 **WHEREAS, the Department of Information & Technology was created to provide our**
2 **Information Technology services to the nation with new and emerging**
3 **technology that will provide support, communication, training, and leadership**
4 **opportunities; and**

5 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2016 Department of**
6 **Information & Technology budget by Resolution Number 15-165; and**

7 **WHEREAS, the Department of Information & Technology has identified the need to replace**
8 **aging equipment; and**

9 **WHEREAS, attached is the justification for purchase and information on Switches, Servers,**
10 **Desktops and Phone System that need to be replaced; and**

11 **WHEREAS, the Budget and Finance Committee of the Legislative Council have reviewed this**
12 **budget and recommend its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
14 **approve and appropriates \$1,370,000.00 from the general fund surplus to fund**
15 **the attached FY 2016 Department of Information & Technology Supplement**
16 **Budget.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **Chairperson and any designated official to expend and administer the budget as**
19 **attached, provided that that any amendments affecting the funds or funding**
20 **level is submitted for further prior approval by the Tohono O'odham Legislative**
21 **Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
23 **day of JANUARY, 2016 at a meeting at which a quorum was present with a vote of 2,931.1 FOR;**
24 **90.3 AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council**
25 **by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
28 **June 18, 1934 (48 Stat.984).**
