9	WHEREAS,	the Human Resources Officer and the Attorney General recommend an Attorney			
10		Contract with the Attorney in the amount of \$15,000 for the period of October 1,			
11		2015 through September 30, 2016; and			
12	WHEREAS,	the 401(k) Trustee budget has sufficient funds for the contract amount; and			
13	WHEREAS,	the Human Resources Development and the Budget and Finance Committees			
14		recommend approval by the Legislative Council of the Attorney Contract.

16		the Attorney Contract for 401(k) matters with the law firm of Yoder & Langford,
