

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for 401(K) Matters with Yoder & Langford,
P.C. for FY2016)**

RESOLUTION NO. 16-030

1 **WHEREAS, the Tohono O'odham Nation has for several years contracted with the law firm of**
2 **Yoder & Langford, P.C. for legal services related to the 401(k) Plan of the Nation**
3 **to assist the 401(k) Trustees and the Human Resources Office; and**

4 **WHEREAS, the Attorney Contract for 401(k) is under the oversight of the Attorney General,**
5 **but is paid for out of the 401(k) budget of the Human Resources Office; and**

6 **WHEREAS, the last such Attorney Contract expired on September 30, 2015; and**

7 **WHEREAS, it is in the best interest of the Nation to continue representation by the Attorney;**
8 **and**

9 **WHEREAS, the Human Resources Officer and the Attorney General recommend an Attorney**
10 **Contract with the Attorney in the amount of \$15,000 for the period of October 1,**
11 **2015 through September 30, 2016; and**

12 **WHEREAS, the 401(k) Trustee budget has sufficient funds for the contract amount; and**

13 **WHEREAS, the Human Resources Development and the Budget and Finance Committees**
14 **recommend approval by the Legislative Council of the Attorney Contract.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
16 **the Attorney Contract for 401(k) matters with the law firm of Yoder & Langford,**
17 **P.C., in the amount of \$15,000 for the period of October 1, 2015 through**
18 **September 30, 2016 substantially in the form attached hereto.**

19 **BE IT FURTHER RESOLVED that the funding for the Attorney Contract shall be provided from**
20 **the 401(k) Trustee budget and that the Chairman of the Nation is authorized to**
21 **execute the Attorney Contract.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
23 **day of JANUARY, 2016 at a meeting at which a quorum was present with a vote of 2,908.15 FOR;**
24 **113.25 AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the**
25 **Council by Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted**
26 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
27 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
28 **the Act of June 18, 1934 (48 Stat.984).**






