1 **WHEREAS, it is advisable that the Human Resources Office has available independent legal**
2 **representation for employment issues in which the Office of Attorney General is**
3 **unable to provide legal advice due to conflicts of interest; and**

4 **WHEREAS, the Human Resources Office recommends an Attorney Contract with The Clark**
5 **Law Firm, P.C. to provide legal representation to the Human Resources Office**
6 **for the foregoing purposes; and**

7 **WHEREAS, the proposed Attorney Contract is in the amount of \$25,500.00 for the period**
8 **from October 01, 2015 through September 30, 2016; and**

9 **WHEREAS, the operating budget for the Human Resources Office (Account No. 001-16-2530-**
10 **7355) for fiscal year 2016 includes sufficient funds for the Attorney Contract; and**


11 **WHEREAS, the Human Resources Development and the Budget and Finance Committees**
12 **recommends approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council hereby approves an Attorney**
14 **Contract with The Clark Law Firm, P.C. in the amount of \$25,500.00 for the fiscal**
15 **year ending September 30, 2016, and in the form attached hereto.**

16 **BE IT FURTHER RESOLVED that the funding for the Attorney Contract in fiscal year 2016 shall**
17 **be provided under the operating budget of the Human Resources Office**
18 **(Account No. 001-16-2530-7355) and that the Chairman of the Nation is**
19 **authorized to execute the Attorney Contract.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
21 **day of JANUARY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
22 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
23 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
24 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
26 **June 18, 1934 (48 Stat.984).**
