

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Extension of the Budget Authority to the FY 2016 Florence
KOHF-LP Radio Project Budget)

RESOLUTION NO. 16-032

1 **WHEREAS, by Tohono O'odham Legislative Council Resolution 15-399, "Amending**
2 **Resolution No. 15-237, 'Approving and authorizing an appropriation and**
3 **allocating general fund surplus for FY 2015 Florence KOHF-LP Radio Project**
4 **budget' to Extend the Budget Authority to FY 2016," the Florence KOHF-LP Radio**
5 **Project (Project) appropriation budget authority was extended into fiscal year**
6 **2016 for the period October 1, 2015, through December 31, 2015; and**

7 **WHEREAS, resolution 15-475, "Approving amendment #1 to the FY 2016 Florence KOHF-LP**
8 **Radio Project budget," re-allocated funds appropriated under the budget to**
9 **permit the completion of the project; and**

10 **WHEREAS, Hewel Ni'ok continues to address the required easements and rights of way,**
11 **which have affected the timely completion of the Project; and**

12 **WHEREAS, the budget authority of the Project's funding expired on December 31, 2015,**
13 **requiring an additional extension; and**

14 **WHEREAS, the Cultural Preservation and the Budget and Finance Committees of the**
15 **Tohono O'odham Legislative Council have reviewed this resolution and**
16 **recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
18 **and authorizes an extension to the FY 2016 Florence KOHF-LP Radio Project**
19 **budget through September 30, 2016.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the**
21 **Chairman and any designated official to expend these funds for the period**
22 **October 1, 2015 through September 30, 2016, provided that any amendments**
23 **affecting the funds or funding level is submitted for further prior approval by**
24 **the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH**
26 **day of JANUARY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
27 **-0- AGAINST; [01] NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council**
28 **by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
31 **June 18, 1934 (48 Stat.984).**


