1 **WHEREAS, the Tohono O'odham Legislative Council approved FY2016 Schuk Toak District**  
2 **and community budgets by resolution No. 15-382; and**

3 **WHEREAS, the Schuk Toak District Council approved by resolution No. ST-01-09-16-004**  
4 **Fresnal Community's FY2016 Budget Amendment No. 1; and**

5 **WHEREAS, the Amendment made to the Fresnal Community's FY2016 Budget will not alter**  
6 **the total budgeted amount of \$162,380.35; and**

7 **WHEREAS, the amendment will add language to line item 7230 *Lease/Rentals*; 7615**  
8 ***Donation/Contribution*; and 7645 *Wake Assistance*; and**


9 **WHEREAS, the Budget and Finance Committee of the Tohono O'odham Legislative Council**  
10 **has reviewed this budget and recommends its approval.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
12 **approves the FY2016 Schuk Toak District-Fresnal Community Budget**  
13 **Amendment No. 1 as attached.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
15 **District Chairperson and any designated official to expend and administer the**  
16 **budget as attached, provided that any modification/amendments affecting the**  
17 **funds or funding level is submitted for further prior approval by the Tohono**  
18 **O'odham Legislative Council**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>**  
20 **day of JANUARY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
21 **-0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**  
22 **Article VI, Section 1(d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the**  
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
25 **June 18, 1934 (48 Stat.984).**
