6	WHEREAS,	a new line item 4850 — Donations and Contributions with an amount of \$500 in						
7		initial received donations was added which will be used to help subsidize						
8		program costs and expenses and support veteran related-events and projects;

10	WHEREAS,	the total budget will increase by \$500 from \$117,976.31 to \$118,476.31 due to the						
11		receipt of \$500 in donations with no change in the amount of general fund						
12		dollars allocated to this budget; and						
13	WHEREAS,	the Veterans Affairs Office has modified the FY 2016 Performance Criteria and						
14		goals to reflect more appropriate and viable program service related activities						
15		with quantifiable performance measurement outcomes as stated in the						
16		attached proposed amendment; and						
17	WHEREAS,	the Human Resources Development and the Budget and Finance Committees of						
18		the Legislative Council have reviewed this budget amendment and recommend						
19		its approval.						
20	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council							
21		(1) Creates a revenue account for donations, contributions, revenues, and						
22		sponsorships to the Veterans Affairs Office, which shall be expended in						
23		accordance with budgets approved by Legislative Council resolution; and						
24		(2) Approves the FY 2016 Veterans Affairs Budget Amendment #1 to add a						
25		new line item 4850- Donations and Contributions with an amount of						
26		\$500 in initial received donations which will be used to help subsidize						
27		program costs and expenses and support veteran related events and						
28		projects in the amount of \$118,476.31 in accordance with the attached						
29		budget.
