6		Diamond Enterprises in the amount of \$44,450; and
7	WHEREAS,	the Tohono O'odham Nation Legislative Council approved the FY 2015-FY 2016
8		Veterans Affairs Supplemental Budget Amendment #1 to expend the
9		sponsorship via Resolution No. 15-368, with a period of July 31, 2015 to
10		December 24, 2015; and
11	WHEREAS	as of September 30, 2015, \$12,012.80 had been expended, leaving a balance of
12		\$32,437.20 of which \$301.34 had not previously been budgeted for; and
13	WHEREAS,	the attached FY 2015-FY 2016 Veterans Affairs Supplemental Budget
14		Amendment #1, increases the budget by \$301.34 from \$32,135.86 to \$32,437.20
15		and extends the period to expend funds through the end of fiscal year of 2016;

17	WHEREAS,	the Human Resources Development and the Budget and Finance Committees of
18		the Legislative Council have reviewed the Budget Amendment #1 and
19		recommend its approval.
