

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Holding February 12, 2016 General Session at Schuk Toak Farms for a Tohono
O'odham Farming Authority Presentation and 2014 Audit Report)

LEGISLATIVE ORDER NO. 16-036

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**
3 **committees, boards and special committees." (Constitution of the Tohono**
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, Article I, Section 2(C) of the Legislative Rules of the Tohono O'odham Legislative**
6 **Council, as amended, provides that "[a]ll Legislative Council sessions shall be**
7 **held at the Tohono O'odham Legislative Council chambers located in Sells,**
8 **Tohono O'odham Nation, with the following exceptions. . . [a] majority of all the**
9 **legislative representatives may vote to hold a session in some location other**
10 **than the chambers located at Sells."; and**

11 **WHEREAS, the Agricultural and Natural Resources Committee has requested the Legislative**
12 **Council hold its February 12, 2016 general session at the Schuk Toak Farms for a**
13 **Tohono O'odham Farming Authority presentation and 2014 audit report.**

14 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that the**
15 **February 12, 2016 general session shall be held at the Schuk Toak Farms for a**
16 **Tohono O'odham Farming Authority presentation and 2014 audit report.**

17 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 29TH day of**
18 **JANUARY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
19 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
20 **Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
21 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
23 **June 18, 1934 (48 Stat.984).**
