## LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Holding February 12, 2016 General Session at Schuk Toak Farms for a Tohono O'odham Farming Authority Presentation and 2014 Audit Report)

**LEGISLATIVE ORDER NO. 16-036** 

1 WHEREAS. the Legislative Council is vested with the power "to establish rules and 2 procedures to regulate all meetings of the Tohono O'odham Council, standing 3 committees, boards and special committees." (Constitution of the Tohono 4 O'odham Nation, Article VI, Section 1(a)); and 5 WHEREAS, Article I, Section 2(C) of the Legislative Rules of the Tohono O'odham Legislative 6 Council, as amended, provides that "[a]ll Legislative Council sessions shall be 7 held at the Tohono O'odham Legislative Council chambers located in Sells. 8 Tohono O'odham Nation, with the following exceptions. . .
