8		Legislative Council appointing the judge, but in no case shall the term be longer
9		than six years" (6 T.O.C. Chapter 1, Article 2, Section 1204); and
0	WHEREAS,	the chief judge has submitted Ms. Violet Lui-Frank's resume, letter of interest,
1		and a letter of recommendation for her appointment as a judge pro tempore to
2		the Tohono O'odham Judicial Court; and
13	WHEREAS,	the Judiciary Committee, having legislative oversight of matters pertaining to
4		the Tohono O'odham Judicial Court, has interviewed Ms. Violet Lui-Frank and
5		reviewed her resume, letter of interest, and the chief judge's letter of
6		recommendation.
