

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Violet Lui-Frank as a Judge Pro Tempore to the Tohono
O'odham Judicial Court)**

RESOLUTION NO. 16-048

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the authority to appoint**
2 **judges to the Tohono O'odham Judicial Court (Constitution of the Tohono**
3 **O'odham Nation, Article VIII, Section 3); and**

4 **WHEREAS, the Legislative Council "may upon the recommendation of the chief judge**
5 **appoint pro tempore judges to the Judicial Court" (6 T.O.C. Chapter 1, Article 2,**
6 **Section 1201); and**

7 **WHEREAS, the term of a judge pro tempore "shall be set forth in the resolution of the**
8 **Legislative Council appointing the judge, but in no case shall the term be longer**
9 **than six years" (6 T.O.C. Chapter 1, Article 2, Section 1204); and**


10 **WHEREAS, the chief judge has submitted Ms. Violet Lui-Frank's resume, letter of interest,**
11 **and a letter of recommendation for her appointment as a judge pro tempore to**
12 **the Tohono O'odham Judicial Court; and**

13 **WHEREAS, the Judiciary Committee, having legislative oversight of matters pertaining to**
14 **the Tohono O'odham Judicial Court, has interviewed Ms. Violet Lui-Frank and**
15 **reviewed her resume, letter of interest, and the chief judge's letter of**
16 **recommendation.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**
18 **appoints Ms. Violet Lui-Frank as a judge pro tempore to the Tohono O'odham**
19 **Judicial Court for a six-year term commencing on the effective date of this**
20 **resolution.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
22 **day of FEBRUARY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
23 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
24 **Article VIII, Section 3 of the Constitution of the Tohono O'odham Nation, adopted by the**
25 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
27 **June 18, 1934 (48 Stat.984).**




