

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Certifying Election of Representative Vernon J. Smith as Tohono O'odham
Legislative Council Vice-Chairperson)

LEGISLATIVE ORDER NO. 16-051

1 **WHEREAS, Article V, Section 4 of the Constitution of the Tohono O'odham Nation provides**
2 **that, "The Tohono O'odham Council shall elect from among its own membership**
3 **a chairman and vice chairman."; and**

4 **WHEREAS, Rep. Racheal Vilson-Stoner was elected Legislative Council vice-chairperson on**
5 **June 12, 2015 by Legislative Order No. 15-227; and**

6 **WHEREAS, on February 08, 2016 the Legislative Council vice-chairperson's office became**
7 **vacant and the Legislative Council conducted an election for vice-chairperson in**
8 **accordance with Article XII, Section 2 of the Legislative Rules of the Tohono**
9 **O'odham Legislative Council; and**

10 **WHEREAS, Representative Vernon J. Smith, having received a majority of the votes cast, was**
11 **declared the Legislative Council vice-chairperson-elect.**

12 **NOW, THEREFORE BE IT ORDERED by the Tohono O'odham Legislative Council that it certifies**
13 **the election of Vernon J. Smith as vice-chairperson of the Tohono O'odham**
14 **Legislative Council.**

15 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 08TH day of**
16 **JANUARY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
18 **Article V, Section 4 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
19 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
20 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
21 **(48 Stat.984).**
