9		Cahan, which details the terms and conditions of his services, a copy of which is
10		attached hereto; and
11	WHEREAS,	the Domestic Affairs and Budget and Finance Committees recommends
12		approval by the Legislative Council of the Professional Services Contract
13		between the Tohono O'odham Nation and Eric Cahan.

15		the Professional Services Contract between the Tohono O'odham Nation and
16		Eric Cahan, in substantially the form attached hereto in an amount not to
17		exceed \$10,000.
