

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2016 Professional Services Agreement with Tucson Unified
School District - Soleng Tom Enrichment Program)**

RESOLUTION NO. 16-061

1 **WHEREAS, the Tohono O'odham Nation provides services to improve the availability,**
2 **affordability and quality of child care through funding received in the Child**
3 **Care & Development Fund Grant for Fiscal Year 2016 from the Department of**
4 **Health and Human Services, Administration for Children and Families; and**

5 **WHEREAS, the Tohono O'odham Nation's Child Care Program wishes to enter into a**
6 **Professional Services Agreement with Tucson Unified School District - Soleng**
7 **Tom Enrichment Program to provide child care services for the Nation's**
8 **children who are eligible to receive child care services; and**

9 **WHEREAS, the Professional Services Agreement has been reviewed by the Human**
10 **Resources Development Committee which recommends approval by the**
11 **Legislative Council.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
13 **approve the Professional Services Agreement for child care services with Tucson**
14 **Unified School District - Soleng Tom Enrichment Program substantially in the**
15 **form attached hereto, and further authorizes the Chairman to execute it.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
17 **day of FEBRUARY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
18 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
19 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**
20 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
22 **June 18, 1934 (48 Stat.984).**
