7	WHEREAS,	the FY 2016 Budget Amendment #1 will bring the Public Safety Personnel
8		Retirement System (PSPRS) rate to the current established rate for FY 2016; and
9	WHEREAS,	amendment #1 changes the Personnel Expense line item by reclassifying two
10		positions; and changes line items 7000 Supplies Office, 7005 Supplies Office
11		Equipment, 7010 Program Supplies, and 7500 Major Capital; and creates a new
12		line item 7020 Kitchen Supplies, all without affecting the total budget; and
13	WHEREAS,	the Domestic Affairs and Budget and Finance Committees of the Legislative
14		Council have reviewed this budget amendment and recommend its approval.
15	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
16		approves the attached FY 2016 Tohono O'odham Police Department West Valley
17		Resort budget amendment #1.
