

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2016 638 Law Enforcement Program Budget Amendment #1)**

**RESOLUTION NO. 16-070**

1 **WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Ranger, and**  
2 **Corrections Programs under the 638 BIA Master Contract; and**

3 **WHEREAS, the Tohono O'odham Nation Law Enforcement, Ranger, and Corrections**  
4 **Programs FY 2016 budget was approved by Tohono O'odham Legislative Council**  
5 **Resolution #15-167; and**

6 **WHEREAS, the FY 2016 Budget Amendment #1 will create line item 7500 Major Capital to be**  
7 **used to cost share with the U. S. DOJ, Sex Offender Registration, Tracking,**  
8 **Enforcement and Notification Division, (SORNA) Program, Award #2015-AW-BX-**  
9 **0011; and**

10 **WHEREAS, the amendment will result in a decrease of Operational Expense line items and**  
11 **Indirect Costs; and**


12 **WHEREAS, the Domestic Affairs and the Budget and Finance Committees have reviewed this**  
13 **budget amendment and recommend it's approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
15 **approves the attached FY 2016 638 Law Enforcement Program Budget**  
16 **Amendment #1.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the**  
18 **Chairman and any designated official to expend and administer the budget as**  
19 **attached, provided that any amendments affecting the funds or funding level**  
20 **shall be submitted for further prior approval by the Tohono O'odham**  
21 **Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
23 **day of FEBRUARY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
24 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
25 **Article VI, Section 1 (d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the**  
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
28 **June 18, 1934 (48 Stat.984).**
