

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Gu-Vo District – Gu-Vo Community Budget Amendment No. 1)

RESOLUTION NO. 16-071

1 **WHEREAS, the Constitution of the Tohono O'odham Nation provides, "No district council**
2 **shall expend district funds except pursuant to budgets authorized under**
3 **resolutions of the district council and approved by the Tohono O'odham**
4 **Council." (Constitution of the Tohono O'odham Nation, Article IX, Section 7); and**

5 **WHEREAS, the FY 2016 Gu-Vo District Budgets in the amount of \$1,772,854.69 were**
6 **approved by Resolution No. 15-387; and**

7 **WHEREAS, after Resolution No. 15-387 were enacted, the Gu-Vo District was advised by the**
8 **Nation's Budget Office that the carry forward funds from FY 1999 for the Gu-Vo**
9 **Community in the amount of \$29,229.76 were previously carried forward and**
10 **expended and are therefore unavailable to fund the FY 2016 Gu-Vo District – Gu-**
11 **Vo Community Budget; and**

12 **WHEREAS, the Gu-Vo District has therefore approved FY 2016 Gu-Vo District–Gu-Vo**
13 **Community Budget Amendment No. 1, which is incorporated by this reference,**
14 **by District Governing Council Resolution No. GV-16-021 and submitted**
15 **Amendment No. 1 for Legislative Council, to reduce the FY 2016 Gu-Vo**
16 **Community Budget by \$29,229.76 from \$179,227.70 to \$149,997.94 by decreasing**
17 **line items by the following amounts:**


1 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2016 Gu-Vo District -**
2 **Gu-Vo Community Budget Amendment No. 1 and recommends its approval.**

3 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
4 **the FY 2016 Gu-Vo District - Gu-Vo Community Budget Amendment No. 1 in the**
5 **amount of \$149,997.76 which will reduce the total amount of the Gu-Vo District**
6 **Budgets from \$1,772,854.69 to \$1,743,624.93.**

7 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
8 **District chairperson and any designated official to expend and administer the**
9 **budget, provided that any modifications or amendments shall be submitted for**
10 **prior approval by the Tohono O'odham Legislative Council.**

11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
12 **day of FEBRUARY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
13 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
14 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
15 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
16 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
17 **(48 Stat.984).**






