

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu Achi District Fiscal Year 2016 Tower User Fees (4th Quarter-2015)
Budget in the Amount of \$31,579.01)

RESOLUTION NO. 16-072

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized to appropriate "funds for**
2 **the benefit of the nation and its members," including the Nation's districts,**
3 **provided that "[n]o district council shall expend district funds except pursuant**
4 **to budgets authorized under resolutions of the district council and approved by**
5 **the Tohono O'odham Council (Constitution of the Tohono O'odham Nation,**
6 **Article VI, Section 1(d)(2), Article IX, Section 7); and**

7 **WHEREAS, the Tohono O'odham Legislative Council approved a Management Agreement**
8 **between the Tohono O'odham Nation, Gu Achi District and the Tohono O'odham**
9 **Utility Authority (TOUA) for Jewek Mountain (Resolution No. 08-586) which**
10 **allowed the Nation and Gu Achi District to obtain a stream of revenue from**
11 **TOUA's leasing space on the transmission tower and the associated equipment**
12 **building; and**

13 **WHEREAS, a Revised Management Agreement was approved by Legislative Council**
14 **Resolution No. 14-412; and**

15 **WHEREAS, on February 5, 2016, the Gu Achi District Council passed Resolution #0216-085**
16 **approving the Gu Achi District Fiscal Year 2016 Tower User Fees (4th Quarter-**
17 **2015) Budget, which is incorporated by this reference, in the amount of**
18 **\$31,579.01 from the revenue of the tower user fees; and**

19 **WHEREAS, the Budget and Finance Committee of the Tohono O'odham Legislative Council**
20 **has reviewed the Gu Achi District Fiscal Year 2016 Tower User Fees (4th Quarter-**
21 **2015) Budget and recommend its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
23 **the Gu Achi District Fiscal Year 2016 Tower User Fees (4th Quarter-2015) Budget**
24 **in the amount of \$31,579.01 from revenue generated tower user fees.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that any modifications**
26 **or amendments to the Gu Achi District Fiscal Year 2016 Tower User Fees (4th**
27 **Quarter-2015) Budget shall be submitted for prior approval by the Tohono**
28 **O'odham Legislative Council.**






