RESOLUTION NO. 16-080

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications**
7 **and making recommendations to the Legislative Council regarding the**
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**
9 **and**

10 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**
11 **O'odham Legislative Council shall determine whether an application is**
12 **approved for membership and its determination, along with the resolution**
13 **number and date of enactment, shall be provided to the applicant; and**

14 **WHEREAS, the Enrollment Program has received the official documents showing the legal**
15 **name changes of enrolled members due to a variety of reasons, such as**
16 **marriage, divorce, or legal adoption; and**

17 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 15-80, 40-**
18 **81, 115-82, 83-83, 197-83, 97-221, 99-140, 2000-003, 05-472 and 12-334 be**
19 **amended to reflect the amended names for the members identified in the March**
20 **2016 Amended Enrollment Resolution Summary, which is incorporated by this**
21 **reference.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
23 **Resolution Nos. 15-80, 40-81, 115-82, 83-83, 197-83, 97-221, 99-140, 2000-003, 05-**
24 **472 and 12-334 are amended upon the effective date of those resolutions to**
25 **reflect the legal name changes for the members identified in the March 2016**
26 **Amended Enrollment Resolution Summary.**
