12		approved for membership and its determination, along with the resolution
13		number and date of enactment, shall be provided to the applicant; and
14	WHEREAS,	the Enrollment Program has received the official documents showing the legal
15		name changes of enrolled members due to a variety of reasons, such as
16		marriage, divorce, or legal adoption; and
17	WHEREAS,	the Enrollment Program therefore recommends that Resolution Nos. 15-80, 40-
18		81, 115-82, 83-83, 197-83, 97-221, 99-140, 2000-003, 05-472 and 12-334 be
19		amended to reflect the amended names for the members identified in the March
20		2016 Amended Enrollment Resolution Summary, which is incorporated by this
21		reference.
