10	WHEREAS,	Article VIII of the Nation's Enrollment Ordinance provides that the Tohono
11		O'odham Legislative Council shall determine whether an application is
12		approved for membership and its determination, along with the resolution
13		number and date of enactment, shall be provided to the applicant; and
14	WHEREAS,	the Enrollment Program has determined that a number of resolutions
15		approving membership and adoption applications misspelled or incorrectly
16		listed the names and/or dates of birth of members; and
17	WHEREAS,	the Enrollment Program therefore recommends that Resolution Nos. 98-294, 98-
18		357, 99-004, 99-039, 99-200, 2000-176, 01-589, 03-280, 05-301, and 15-362 be
19		amended to reflect the correct name and/or date of birth for the members
20		identified in the March 2016 Corrected Enrollment Resolution Summary, which
21		is incorporated by this reference.
22	NOW, THER	EFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that
23		Resolution Nos. 98-294, 98-357, 99-004, 99-039, 99-200, 2000-176, 01-589, 03-280,
