

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Accepting Funding From the Special Diabetes Program for Indians and Approving  
the FY 2016 Healthy O'odham Promotion Program Budget)**

**RESOLUTION NO. 16-084**

1 **WHEREAS, the Tohono O'odham Nation ("Nation") receives grant funding from the Special**  
2 **Diabetes Program for Indians ("SDPI"), which is a program administered by the**  
3 **United States Department of Health and Human Services, Indian Health Service,**  
4 **Division of Diabetes Treatment and Prevention to address the growing epidemic**  
5 **of diabetes among American Indian and Alaska Native communities; and**

6 **WHEREAS, by Resolution No. 98-149, the Tohono O'odham Legislative Council approved the**  
7 **establishment of the Community Based Diabetes Prevention Program, which is**  
8 **funded by the SDPI; and**

9 **WHEREAS, by Resolution No. 2000-182, the Tohono O'odham Legislative Council approved**  
10 **the name change of the Community Based Diabetes Prevention Program to the**  
11 **Healthy O'odham Promotion Program ("HOPP"); and**

12 **WHEREAS, the HOPP was notified of a new grant funding cycle for the SDPI program and the**  
13 **HOPP has submitted a proposal through the Nation's Grants and Contract**  
14 **Office, with a program period from January 1, 2016 through December 31, 2020**  
15 **for such funding; and**

16 **WHEREAS, the HOPP received notification it received an award of \$2,241,130.00 from SDPI**  
17 **and the HOPP has prepared the attached New Cycle FY 2016 budget for the**  
18 **period of January 1, 2016 through December 31, 2016 in the amount of**  
19 **\$2,241,130.00; and**

20 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**  
21 **Legislative Council have reviewed the attached budget and recommend its**  
22 **approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts the**  
24 **funding award from SDPI in the amount of \$2,241,130.00, approves the attached**  
25 **FY 2016 Healthy O'odham Promotion Program budget in the amount of**  
26 **\$2,241,130.00 for the period of January 1, 2016 to December 31, 2016, and**  
27 **authorizes the HOPP to utilize the Nation's general fund pending**  
28 **reimbursement from SDPI for the continuation of this grant.**



7 **day of MARCH, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
8 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
9 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
10 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
11 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
12 **June 18, 1934 (48 Stat.984).**
