8		2015, the Workforce Investment Act transitioned into Workforce Innovation &
9		Opportunity Act (WIOA); and
10	WHEREAS,	IGA DE15-077080 Contract Amendment #2 has been proposed by ADES to
11		decrease unobligated fund balances totaling \$289,385 for the Program Year (PY)
12		2014 and Fiscal Year (FY) 2015 and to revise the end date of this
13		intergovernmental agreement from June 30, 2018 to December 31, 2016; and
14	WHEREAS,	the unobligated WIA funds will be added to the WIOA contract once it is in place;

16	WHEREAS,	the Human Resources Development and Budget and Finance Committees of the
17		Legislative Council have reviewed the PY14/FY15 IGA Amendment #2 and
18		recommend its approval.
