

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Tohono O'odham Nation Youth Council Program Budget Amendment #1)

RESOLUTION NO. 16-087

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the power "to adopt, approve and amend annual budgets and to authorize**
3 **the expenditure of funds in accordance with these budgets." (Constitution,**
4 **Article VI, Section 1(d)(3)); and**

5 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 2016 Tohono O'odham**
6 **Nation Youth Council Program Budget by Resolution No. 15-165; and**

7 **WHEREAS, the Tohono O'odham Nation Youth Council Program has prepared and**
8 **submitted, for review and approval, FY 2016 Budget Amendment #1; and**

9 **WHEREAS, the proposed Budget Amendment #1 will create line items 7310-Employee**
10 **Clearance and 7400-RM Equipment; and**

11 **WHEREAS, the budget amendment changes the amounts of certain Operational Expense**
12 **line items with no change to the base budget amount; and**

13 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
14 **reviewed this budget Amendment #1 and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
16 **approves the FY 2016 Tohono O'odham Nation Youth Council Program Budget**
17 **Amendment #1 as attached hereto which will:**

- 18 **1. Create new line items 7310-Employee Clearance and 7400-RM**
19 **Equipment.**
- 20 **2. Change amounts of certain Operational Expense line items.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**
22 **the Chairman and any designated official to expend and administer the budget**
23 **as attached, provided that any amendments affecting the funds or funding level**
24 **is submitted for further prior approval by the Tohono O'odham Legislative**
25 **Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
27 **day of MARCH, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
28 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the**
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
32 **June 18, 1934 (48 Stat.984).**
