5		subdivisions, or with private persons or organizations on all matters within the
6		authority of the Tohono O'odham Council." (Constitution, Article VI, Section
7		1(f)); and
8	WHEREAS,	the Tohono O'odham Nation has consistently supported the pursuit of higher
9		education for its members; and
10	WHEREAS,	in 2010 a License Agreement, which was subsequently approved by Legislative
11		Council Resolution No. 13-465, with Pima Community College was executed to
12		provide the Education Department office space at the College's Desert Vista
13		Campus; and
14	WHEREAS,	in an effort to update the terms of the License Agreement the 2010 License
15		Agreement was terminated on June 30, 2015; and
16	WHEREAS,	the Tohono O'odham Nation Education Department seeks to enter into a new
17		License Agreement with Pima Community College; and
18	WHEREAS,	the Human Resources Development and Budget and Finance Committees of the
19		Legislative Council have reviewed the Facility License Agreement with Pima
20		Community College, which is incorporated by this reference, and recommends
21		approval by the Tohono O'odham Legislative Council.
22	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves
23		the Facility License Agreement between Pima Community College and the
24		Tohono O'odham Nation, in substantially the form attached hereto, and
25		authorizes the Nation's Chairman to execute the License Agreement.
