

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY-2016 Solid Waste Management Program Budget Amendment #1)

RESOLUTION NO. 16-094

1 **WHEREAS, the Tohono O'odham Legislative Council approved the Solid Waste Management**
2 **Program ("SWMP") FY 16 budget by Resolution No. 15-195 in the amount of**
3 **\$1,820,436.37; and**

4 **WHEREAS, SWMP has identified a need to adjust Operational Expense line items and to**
5 **correct salary errors for two positions, which appear in the FY 16 budget; and**

6 **WHEREAS, budget amendment #1 provides for the addition of line items 6500 Training Fees**
7 **and Registration and 7355 Professional Services and decreases and increases**
8 **Operational Expense line items; and**

9 **WHEREAS, the budget amendment also corrects the salary amounts for two Equipment**
10 **Operator/Driver II positions by utilizing funding from vacant positions, which**
11 **results in no change in the budget amount; and**

12 **WHEREAS, the Agricultural and Natural Resources and the Budget and Finance Committees**
13 **of the Legislative Council have reviewed this budget amendment and**
14 **recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
16 **approves FY-2016 Solid Waste Management Program Budget Amendment #1 in**
17 **accordance with the attached budget:**

- 18 1. **Approve the addition of Operational Expense line items.**
- 19 2. **Approve the increase and decrease of Operational Expense line items.**
- 20 3. **Approve the correct salary amounts for two Equipment Operator/Driver II**
21 **positions.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
23 **Chairperson and any designated official to expend and administer the budget as**
24 **attached, provided that any amendments affecting the funds or funding level is**
25 **submitted for further prior approval by the Tohono O'odham Legislatiave**
26 **Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
28 **day of MARCH, 2016 at a meeting at which a quorum was present with a vote of 3,021,4 FOR; -0-**
29 **AGAINST; [01] NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the**
31 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
33 **June 18, 1934 (48 Stat.984).**


